Frequency /Market Exposure Campaign participants will appear in each of the four newspapers and the chamber newsletter once per month for a total of five ads monthly, plus internet exposure on The Daily Herald, North County Outlook, The Marysville Globe, The Arlington Times and the Chamber Web sites (total 320,000+ visits monthly) and city television reaching North Snohomish County residents and businesses.

Levels of Campaign Investment

Chamber Member Pricing

\$50 a month offers three times the space for only twice the investment. Buy Local supporters may purchase additional display ad units for a larger size display advertisement. Includes your company name, logo, address, phone, Web site.

\$25 a month – features your company name and phone number *or* web address url.

Non-Member Pricing

\$75 a month includes your company name, logo, address, phone, Web site. Buy Local supporters may purchase additional display ad units for a larger size display advertisement.

\$35 a month – features your company name and phone number *or* web address url.

Terms of contract Campaign investors agree to make full payment in advance for the 6 month term, from September 21, 2009 through March 21, 2010 or may authorize the Chamber (via The Daily Herald) to charge their credit card monthly. Participants agree to display Buy Local signage on site.

Contract Renewal This contract will automatically renew for a new six month period upon conclusion of the current six month contract unless either party signals a desire not to renew. Payment required in advance of each new six month period. Advertiser agrees to display Buy Local Cling in store front and on Web site.

General Conditions In consideration of such publication, the advertiser and its agency agree to indemnify and hold the publishers harmless against any expenses by reason of any claims arising out of publications.
